## 1. Philosophy

At The Federation of Wood Street Infant School & Worplesdon Primary School we believe in the importance of relationships, ensuring children feel valued, safe and secure, providing a sense of connection with a member of staff and a belonging to the whole school community.

We give pupils opportunities to develop the skills needed to become well-rounded, articulate, independent and confident members of a constantly evolving society, valuing themselves and others and feeling inspired by the world around them using the following four curriculum drivers at the core:

- building resilience
- inspiring curiosity
- promoting teamwork and independence
- instilling empathy

These drivers are our core values and they run through all the school policies and practice.

## 2. The purpose and scope of this policy

The Federation of Wood Street Infant School & Worplesdon Primary School (WWFS) works with children and families to ensure they:

- protect children and young people who take part in WWFS's services, events and activities, specifically those where photographs and videos may be taken
- set out the overarching principles that guide our approach to photographs/videos being taken of children and young people during our events and activities
- to ensure that we operate in line with our values and within the law when creating, using and sharing images of children and young people.

This policy statement applies to all staff, volunteers and other adults associated with WWFS.

## 3. Legal framework

This policy has been drawn up on the basis of legislation, policy and guidance that seeks to protect children in England. Summaries of key legislation and guidance is available on NSPCC Learning:

We believe that:

- children and young people should never experience abuse of any kind
- we have a responsibility to promote the welfare of all children and young people and to take, share and use images of children safely.

## Photography & Filming Policy

We recognise that:

- sharing photographs and films of our activities can help us celebrate the successes and achievements of our children and young people, provide a record of our activities and raise awareness of our organisation
- the welfare of the children and young people taking part in our activities is paramount
- children, their parents and carers have a right to decide whether their images are taken and how these may be used, regardless of age, disability, gender reassignment, race, religion or belief, sex or sexual orientation
- consent to take images of children is only meaningful when children, their parents and carers understand how the images will be used and stored, and are fully aware of the potential risks associated with the use and distribution of these images
- there are potential risks associated with sharing images of children online.

We will seek to keep children and young people safe by:

- always asking for written consent from a child and their parents or carers before taking and using a child's image
- always explaining what images will be used for, how they will be stored and what potential risks are associated with sharing images of children
- making it clear that if a child or their family withdraw consent for an image to be shared, it may not be possible to delete images that have already been shared or published
- changing the names of children whose images are being used in our published material whenever possible (and only using first names if we do need to identify them)
- never publishing personal information about individual children and disguising any identifying information (for example the name of their school or a school uniform with a logo)
- making sure children, their parents and carers understand how images of children will be securely stored and for how long (including how we will control access to the images and their associated information)
- reducing the risk of images being copied and used inappropriately by:
  - ❖ only using images of children in appropriate clothing (including safety wear if necessary)
  - ❖ avoiding full face and body shots of children taking part in activities such as swimming where there may be a heightened risk of images being misused
  - ❖ using images that positively reflect young people's involvement in the activity.

We expect:

- our community to act with **Respect** – all parents and children have rights and we expect our community to respect the online safeguards we have put in place.
- our community to act with **Consideration** – as a school we are aware that legal boundaries constrain actions and we are held accountable and we expect our community to support this. Laws relating to defamation, copyright and data protection apply when using social media (other laws may also apply). The school can be held liable for your actions so if you are unsure about whether you are acting within the law you should seek further legal clarification.

We will also develop a procedure for reporting the abuse or misuse of images of children as part of our child protection procedures. We will ensure everyone involved in our organisation knows the procedures to follow to keep children safe.

In the event that a person breaches this policy, the breach will be recorded by the Executive Headteacher and reported to the governing body who will request a meeting with all parties involved with the breach to decide next steps.

### 4. Photography and/or filming for personal use

When children themselves, parents, carers or spectators are taking photographs or filming at our events and the images are for personal use, we will publish guidance about image sharing in the event programmes and/or announce details of our photography policy before the start of the event (***wording below in bold italics***). This includes:

- reminding parents, carers and children that they need to give consent for WWFS to take and use their images
- asking for photos taken during the event not to be shared on social media or asking people to gain written permission from children, their parents and carers before sharing photographs and videos that include them
- recommending that people check the privacy settings of their social media account to understand who else will be able to view any images they share
- reminding children, parents and carers who they can talk to if they have any concerns about images being shared.

***We appreciate photos and videos can be special mementos and you're welcome to take some for your personal use. However, we must remind you that we take safety very seriously, people are vulnerable in ways you cannot always see and we need to be mindful of protecting our pupils, staff and our community. Therefore you cannot forward the photos you take in any way until the parent of every child in the photo/video has given you written consent. If you ignore this caution, please consider you are personally responsible for any chain of events which could follow.***

### 5. Photography and/or filming for WWFS's use

We recognise that our group leaders may use photography and filming as an aid in activities such as music or drama. However, this should only be done with the headteacher's permission and using WWFS equipment.

Children, young people, parents and carers must also be made aware that photography and filming is part of the programme and give written consent.

If we hire a photographer for one of our events, we will seek to keep children and young people safe by:

- providing the photographer with a clear brief about appropriate content and behaviour
- ensuring the photographer wears identification at all times
- informing children, their parents and carers that a photographer will be at the event and ensuring they give written consent to images which feature their child being taken and shared
- not allowing the photographer to have unsupervised access to children
- not allowing the photographer to carry out sessions outside the event or at a child's home
- reporting concerns regarding inappropriate or intrusive photography following our child protection procedures.

### 6. Photography and/or filming for wider use

If people such as local journalists, professional photographers (not hired by WWFS) or students wish to record one of our events and share the images professionally or in the wider world, they should seek permission in advance.

They should provide:

- the name and address of the person using the camera
- the names of children they wish to take images of (if possible)
- the reason for taking the images and/or what the images will be used for
- a signed declaration that the information provided is valid and that the images will only be used for the reasons given.

WWFS will verify these details and decide whether to grant permission for photographs/films to be taken. We will seek consent from the children who are the intended subjects of the images and their parents and inform the photographer of anyone who does not give consent.

At the event we will inform children, parents and carers that an external photographer is present and ensure the photographer is easily identifiable, for example by issuing them with a coloured identification badge.

If WWFS is concerned that someone unknown to us is using their sessions for photography or filming purposes, we will ask them to leave and (depending on the nature of the concerns) follow our child protection procedures.

### 7. If consent to take photographs is not given

If children, parents and/or carers do not consent to photographs being taken, we will respect their wishes. We will agree in advance how they would like to be identified so the photographer knows not to take pictures of them, and ensure this is done in a way that does not single out the child or make them feel isolated.

We will never exclude a child from an activity because we do not have consent to take their photograph.

### 8. Storing images

We will store photographs and videos of children securely, in accordance with our safeguarding policy and data protection law.

We will keep hard copies of images in a locked drawer and electronic images in a protected folder with restricted access. Images will be stored only up to the time the child leaves WWFS. We will never store images of children on unencrypted portable equipment such as memory sticks and mobile phones.

WWFS does not permit staff and volunteers to use any personal equipment to take photos and recordings of children. Only cameras or devices belonging to the WWFS should be used.

### 9. Related policies and procedures

This policy statement should be read alongside our organisational policies and procedures, including:

- Safeguarding and child protection policy and procedures.
- Code of conduct for staff and volunteers.
- Online safety policy and procedures for responding to concerns about online abuse.
